Shaping the Crown's Approach to the New Zealand Screen Sector

Portfolios Arts, Culture and Heritage / Economic and Regional Development

On 14 April 2021, the Cabinet Economic Development Committee (DEV):

- noted that as part of Budget 2019, Cabinet invited the Minister for Arts, Culture and Heritage, and the Minister for Economic Development jointly to report back to DEV on the fiscal sustainability of the New Zealand Screen Production Grant (NZSPG) [CAB-19-MIN-0174.05];
- 2 **noted** that based on current policy settings, forecasts suggest that:
 - 2.1 total Crown funding for the sector will reach \$594 million in 2024/25 (\$450 million of this will be the NZSPG, which is a demand driven and uncapped incentive);
 - 2.2 the NZSPG may not be fiscally sustainable in its current form;
- noted that current screen sector institutions and funding arrangements may not be creating the right incentives to maximise the potential return on the Crown's investment in the sector, and instead may support volume-based rather than value-based growth;
- 4 **noted** that there are significant developments and longstanding challenges that also require a government response, including:
 - 4.1 responding to Australian sectoral reforms and the industry's 2030 strategy;
 - 4.2 ensuring that the Crown's wider investment in the sector, including funding agencies, remains fit for purpose;

5 S9(2)(g)(i)

- **invited** the Minister for Arts, Culture and Heritage and the Minister for Economic and Regional Development to report back to DEV by September 2021, on:
 - 6.1 the Crown's key objectives for investment in, and support for, the sector, both in terms of its potential cultural and economic benefit;
 - 6.2 the scope of the subsequent work programme to review Crown support for the sector, including potential further work required to maximise value and improve discretion over investment;

- 7 **invited** the Minister for Arts, Culture and Heritage to prepare and take forward an initial government response to the industry's 2030 strategy, in consultation with the Minister for Economic and Regional Development;
- 8 **noted** that there are high returns and global competition for talent across different subsectors of the technology sector, namely the screen and gaming sub-sectors;
- 9 **invited** the Minister for Economic and Regional Development and the Minister for the Digital Economy and Communications to investigate opportunities and challenges for developing the gaming sector in New Zealand through the Digital Strategy for Aotearoa and the Digital Technologies Industry Transformation Plan.
