Dear 9(2)(a)

I refer to your request received on 4 February 2021, which has been considered under the Official Information Act 1982 (OIA), for the following information.

- I would like a list of all New Zealand persons, organisations, or activities that have been granted permission to use the word Royal.
- I would like a list of any undertakings that are lawfully exempt from needing permission, excluding those in connection to having Royal as a surname or place name.
- Who has been prosecuted for not having permission?
- When prosecution wasn't undertaken, what were the reasons not to? For example, a warning for a first time offence was deemed sufficient.

In our subsequent communication, you refined the scope of your request to cover the date range from 2008 to present, "even if the picture you have is incomplete and comes with many caveats".

The attached table provides details of organisations or activities that have been granted permission to use the word Royal in New Zealand, or are exempt from needing permission. This is noted in the 'Approved/Exempt' column. For those approved, this column notes 'Approved', for exempt this column notes 'Exempt'. Please note that records prior to 2014 are incomplete and cannot be verified within this timeframe.

With reference to your second question on undertakings that are lawfully exempt from needing permission, excluding those in connection to having Royal as a surname or place name, the following exemptions apply under the Flags, Emblems, and Names Protection Act 1981:

- Section 12(4)(b) provides that "nothing in this section shall limit or affect section 24 of the Trade Marks Act 2002 (which relates to the representation in trade marks of Her Majesty or any members of the Royal Family)".
- Section 14(4)(a)(i) & (ii) provides that nothing in this Act shall prohibit the use of a name or word that has been "expressly authorised by or under any other Act, or by Her Majesty or the Governor-General".
- Section 22 provides that "Nothing in this Act shall prohibit or affect the use by any person of any emblem, name, representation, or word if, immediately before the commencement of this Act, that use was expressly authorised by any consent, permission, approval, or authority given by any person lawfully entitled to give it".

There have been no prosecutions for use of the word Royal without permission.

Our Enforcement and Prosecution Policy may be found on Manatū Taonga, the Ministry for Culture and Heritage website www.mch.govt.nz/about-ministry/legislation. This includes a number of measures to address potential unauthorised use, before prosecution. In general, the Ministry's preference is to take an educative rather than an enforcement approach in the first instance. There are no records that there have been any formal warnings for unauthorised use.
